UTILITY DONATION PROGRAM – SCHOA REQUESTS “YOUR” SUPPORT

The EPCOR Wastewater Rate Case is over with the exception of the final Administrative Law Judge’s Ruling and Approvals from the Commission.

With the assistance of the RCSC, the Retirement Community Association of Sun City, Town of Youngtown, LD21 Legislators and RUCO (Residential Utility Consumers Office) Sun City residents put out a stellar effort against the forced subsidy EPCOR and the Corporation Commission Staff have proposed which would effect a 78% wastewater rate increase on the Sun City District ratepayers.



SCHOA has given its best effort in the fight against this proposed socialization program which would have the District paying approximately a \$5M per year subsidy to the other four districts. We believe our case is strong and should prevail. You can judge for yourself by going to the “SCHOA in the News” section on the SCHOA website and read the documents posted. The two legal briefs provide a strong sense of our position.

This case is important not only as a standalone, but for future cases as well; particularly as the Commission has ordered EPCOR to file another Water Rate Case no later than 2019 to again review the policy of “Consolidating the EPCOR Water Districts.” EPCOR has announced they will file in 2018.

The impact of consolidating the EPCOR water districts appears to be far worse for Sun City Ratepayers than the Wastewater consolidation.

It looks to me regardless of the outcome of the current case, in order for SCHOA to properly continue its utility

fight on behalf of the Sun City Residents going forward, we will need funding we currently do not have.

These cases are extremely complicated and expensive to manage. The legal and ancillary costs can easily exceed \$85K per case.

I am of the opinion that SCHOA should set up a fund to handle these utility cases. **The funding has to be generated by the community.** I would suggest a \$15.00 donation to such a fund by each household in Sun City. I realize all the households would not participate. However, if 15,000 homeowners donated \$15.00 there would be an excess of \$200,000 which would cover an appeal and the next rate case as well as any cases that may follow.

If we were to consolidate in the current wastewater case alone, each home would have a \$15/month increase (may be prorated over 3-5 years). I believe a \$15.00 investment by Sun City ratepayers would make a lot of sense.

I ask you to email (Marketing@suncityhoa.org) or write a letter to SCHOA (10401 W Coggins Drive, Sun City, AZ 85351) indicating whether or not you would support such a program. We will monitor your comments over the next month prior to making a final determination. All SCHOA members will receive an email blast allowing them to respond with their opinion easily. These are serious issues that take serious actions. SCHOA expresses its appreciation to all who have been involved in this case and hope we can continue the fight moving forward together.

SENATOR LESKO UPDATES SUN CITY

I'm working hard at the AZ State Capitol. In addition to working on the state budget...here is some of the legislation I've sponsored:

SB1441 gives patients that have received a "surprise" medical bill from an out of network doctor a way to settle the bill.

SB1431, my ESA legislation, provides another option for parents to find the best education for their child.

SB1442, my pension reform legislation, will help make the Correction Officer Retirement Plan sustainable for the employees and reduce risk to the taxpayer. The current plan is 53% funded. It is supposed to be funded at 100%. This effort

follows my success at reforming the police and fire pension plan last year.

SB1327 initiates the establishment of a Gold Star Family memorial at Wesley Bolin Plaza by the state capitol. The memorial will honor military members killed in action and their families. Governor Ducey signed the bill into law.

It is the first major acquisition for Maricopa County Parks in roughly a quarter century.

SUN CITY HISTORY TIDBITS “Stepping Up to the Plate”

Baseball’s Cactus League spring training baseball season has again come and gone with scores of local residents joining in the fun by trekking to a game or more. Others find another volunteering opportunity by offering their help with parking, collecting tickets, working concessions, or hawking programs at various area stadiums during the month of March. In fact, Sun City residents, since opening day in January 1, 1960, have “stepped up to the plate” and earned Sun City the title: “City of Volunteers.”

Del Webb, our founder, had a lifetime interest in baseball culminating with partnering with Dan Topping to purchase the New York Yankees. As a result, visitors to the Del Webb Sun Cities Museum are not surprised when learning Sun City hosted a professional women’s softball team for several seasons—the Sun City Saints. That was just for warm ups. Next Webb built a stadium at 111th Avenue and Grand Avenue that played host to the Milwaukee Braves for several spring training seasons. Baseball legends like Henry Aaron sharpened their skills practicing in Sun City while eagerly waiting their turn to step up to the plate while thinking, “Home Run!”

That is precisely what SCHOA has been doing since its inception in 1961—stepping to the plate, swinging for the fences, attempting to hit it out of the park for its residents time after time. In 1998 the fences were made of cement blocks as they are in 2017. And again many are in need of both paint and repair.

For all the “home runs” Del Webb hit in developing Sun City, he also struck out a few times. Building miles and miles of fences, or in this instance walls, was really a great idea. Not establishing ownership or maintenance responsibility for those walls when finishing the community in 1978 was a classic swing and a miss for Webb.

When everyone else ducked responsibility including Maricopa County, individual property owners, condo associations, etc., SCHOA stepped up to the plate in 1998, formed a (501)(c) 3 corporation and organized a community team of hundreds of residents who donated what they could and the \$158,000 to repair, pressure wash and paint the walls was completed in time for the 40th Anniversary celebration in 2000. Those donors joined, by stepping up to the plate, with SCHOA and together they knocked it out of the park.

Here we are in 2017, and it is game on once again. SCHOA again formed a (501)(c) 3 corporation—Sun City Residents Assistance Program, Inc. (SCRAP) to receive tax deductible donations. SCRAP, Inc. now stands in the batter’s box ready to swing for the fences on behalf of all of us one more time. And they are good. We have already seen some of their early hits—portions of Bell Road, Olive Avenue, Boswell, Lindgren, Alabama and 99th Ave. But they are not laying down that bat until they have knocked it out of the park and the walls are done once more. Now is the time for all of us to “step up to the plate” once more by making a contribution to the wall painting project. As administrator of the Sun City Community Fund, during the month of April, SCHOA assisted Sun City residents with medical bills, rent, household repairs and assistance with dead-tree removal and yard cleanup. This cash fund helps Sun City neighbors who are experiencing financial emergencies. Support comes for a wide variety of financial crises. Medicine, home repairs and appliance replacement, dental work, rent and mortgage payments and car repairs are examples of the help the Fund provides our neighbors.

The only income for the Personal Needs Fund comes from Sun City residents who want to help their neighbors. And, 100% of the funds raised in Sun City remain in Sun City! More than 1,700 residents received a myriad of services last year. A great number of additional people were affected by our help.

The Sun City Community Fund is Valley of the Sun United Way at work in Sun City. The SCHOA staff members administering the Personal Needs Fund have the full resources of the entire United Way organization and its more than 100 partners to complement local resources. SUN CITY COMMUNITY ASSISTANCE NETWORK (Sun City CAN)

Sun City Community Assistance Network (Sun City CAN) and Sun Valley Lodge have partnered to provide a new resource for low-income Sun City residents. It is called Free Respite Care and will provide temporary institutional care at Sun Valley Lodge for dependent elderly, ill or handicapped persons, thereby providing temporary relief for their usual caregivers. Both Sun Valley Lodge and Sun City CAN are 501(c) 3 nonprofits. The patients of those caregivers who are selected for the program will receive three days of free respite care from Sun Valley Lodge every three to six months

Depending upon the availability of funds. Sun Valley Lodge is giving Sun City CAN a reduced daily rate for two of the three days and Sun Valley Lodge is providing the third day free of charge. For further information, contact Sun City CAN at 623-933-7530.

THE PRIDES

Sun City PRIDES – A Historical Perspective

The Sun City PRIDES (Proud Residents Independently Donating Essential Services) has a long and valued history in Sun City. The PRIDES was established in 1980 as a service organization whose sole purpose was to keep Sun City beautiful.

It began as the result of a letter to the editor written by Joe McIntyre, a Sun City resident, complaining about the litter along 99th Avenue. He noted that he was out there every Saturday morning trying to clean up the litter, but needed the help of other Sun City residents. Within two months, several meetings were held with appointed officials for the PRIDES along with representatives from Maricopa County and the Del Webb Corporation. Joe McIntyre was unanimously appointed PRIDES Chairman. Early tasks focused on litter clean-up and picking up oranges from thousands of ornamental orange trees. This was supported by the over 200 volunteers that stepped forward to make the PRIDES a viable and valued organization.

In 1982, Al Brown worked to have the PRIDES successfully become a non-profit corporation with tax-exempt status. With donations rolling in and membership peaking at 300 in 1984, the Sun City Water Company approved plans for a PRIDES' building to be built using PRIDES funds on their land at the intersection of Greenway Road and 91st Avenue. The PRIDES pay a \$1 per year lease. The building is called the "Vern and Carol Howland Building" in

honor of Vern and Carol’s generous energies working with the PRIDES. The PRIDES Park was established at West Peoria Avenue and 105th Avenue in 1987. Then in 1990, former governor Rose Mofford awarded the PRIDES the Governor’s Pride in Arizona Award. Following the “Great Storm of 96,” the PRIDES were mobilized to clean up the Sun City streets of vegetation and other debris in the aftermath of the storm.



Since then, the PRIDES continue to have a strong relationship with the Maricopa County Department of Transportation and elected officials, including Maricopa County Supervisor Clint Hickman. Work progresses replacing orange trees with drought-tolerant bushes and trees as part of the Project Desert Canopy under the guidance of the PRIDES Beautification Committee.

PRIDES president Ken Smith said, “I was humbled to be elected to such an organization where its members are so passionate about their neighborhood. We are unique in what we do.” The PRIDES motto is “Keeping Sun City Beautiful.”

Mr. Smith went on to note that over the decades there have been thousands of PRIDES members, including many who stepped forward to assume leadership positions on the PRIDES board of directors and participate on various PRIDES committees. Continuing a family tradition, Joe McIntyre’s great-granddaughter Kenzie Willneff is joining the PRIDES. It should be noted that the PRIDES do not have a fund drive, instead depending on donations from citizens, clubs, and businesses to support their mission of “Keeping Sun City Beautiful.”

FREE LOCK BOX PROGRAM

The Sun City Fire Department has a program that installs lock boxes on Sun City residencies. The boxes are installed adjacent to the front door. Inside the box is a key to the front door which will allow Fire Department personnel to enter the residence in an emergency when the occupant is incapacitated. Otherwise, there would have to be a forced entry with resulting property damage. Normally the cost of installing a lock box is \$65, but Sun City Community Assistance Network (Sun City CAN) has a program that provides lock boxes at no cost to certain low income residents. The program is currently only available to persons who live alone since they are the most vulnerable.

ROADS AND SAFETY COMMITTEE

The Roads and Safety Committee meets the third Wednesday of each month at the SCHOA office with the exception of July and August. This is a community opportunity to learn what is happening with road and safety improvements and upgrades in Sun City. Residents are invited to attend and bring their questions, comments and concerns. Representatives from various government agencies attend and are available to respond to questions from residents.

COMPLIANCE CORNER

Weeds

Every spring we all look forward to warming temperatures and more sunshine. We spend outside a little more and enjoy the beautiful weather and flowers in bloom. In the Compliance Department, we also notice the proliferation of weeds. I saw one definition of a weed which I thought was accurate: a weed is often "a flower growing where it is unwanted." As good neighbors here in Sun City, let's all ensure we maintain our properties in a weed-free and attractive manner as required by our CC&R's.



African Daisies and Other Weeds (Condition of Property, paragraph 11 of CC&R's)

I don't know anyone who doesn't like or love flowers. Most of us in Sun City were either well into adulthood when the flower children of the 60's were blossoming, or we were them. Flowers have always been symbolic of love, peace, and good wishes. Who could possibly not love that?

Well, when it comes to African Daisies, the Compliance Department has collectively decided that we do not like these "flowers." We don't like them because they are not in your best interests as homeowners. Here is the logic and reasoning:

Every year we have a number of well-meaning, peaceful, and loving citizens who allow the African Daisies to grow and to flower. We hear of how beautiful they are when they flower, and of the joy they bring as they flower. Here's

the problem; they are not part of the desert landscaping plan at these homes, and most of the time they look like weeds. They are weeds; they are not a planned part of the landscape. They are random. They result in the appearance of landscaping not being maintained properly, which it must be under paragraph 11 of our CC&R's. It detracts from the appearance and value of neighboring properties, which is another violation. The flowering results in seeds blowing peacefully and lovingly onto the neighboring properties, much to the dismay of those neighbors, who have always probably viewed them as weeds.

Our job as Compliance Officers is to fairly and consistently enforce the CC&R's to protect the property values in Sun City. To be consistent regarding African Daisies, we will in the future view them as WEEDS whenever they are obviously not a part of the landscape design. Sorry.
